JPEG/TIFF FILE ENTRY

NWS will accept ONE entry in either a slide or in a digital graphic file. We prefer to receive only JPEG or TIFF files (72 ppi minimum). Other formats may not open properly or at all.

INSTRUCTIONS

- Please complete the Data Card and be sure to sign it.
- Enclose a check for \$20.00 (to NWS)
- Enclose a Self Addressed Stamped Business Size Envelope for return status letter.
- The JPEG/TIFF file should be attached to an e-mail and sent to:

- Please include your name, address, phone, and e-mail address in the body of the message.

All e-mails will be acknowledged upon receipt. Graphic files may also be submitted on CD or flash sticks. CDs will NOT be returned to the artist. Flash sticks (thumb drives) **will be returned** to the artist because they are re-useable media. (NO DVD disc submissions.)

Do not send as Registered/Certified Mail

Please note that the e-mail address above is valid only for submission of files to the NWS All Member Show. It will be closed after March 7, 2010.

ELIGIBILITY

NWS Signature and Associate members whose dues are paid for the current year may submit **ONLY** one slide or one JPEG/TIFF file. Work must be water-based media **ON PAPER**. Slide must be 35 mm color in a 2" x 2" mount. No glass slides will be accepted. No tape or attached labels should be used. The digital file must be in JPEG or TIFF format and with a resolution of at least 72 ppi. Files attached to e-mails may be up to 5MB in size. Larger files should be submitted on CD or flash drive. Do not submit an image on DVD disc.

Your source material must be your own design or your own photograph. No work taken from published photographs will be accepted. Paintings done in class or workshops must not be submitted.

JURYING PROCEDURES

The slides will be scanned and digitized and incorporated with all the other digital entries. JPEG/TIFF files will be put on a disk and sent to the juror. Awards will be chosen from the actual accepted entries by the juror.

NWS AWARDS \$5,000 in Cash Awards

ENTRY FEE

Members may submit one slide or one JPEG/TIFF file with an entry fee of **\$20.00**. Check is payable to NWS.

Artists may join as Associates any time during the year. Dues are **\$40.00** for Associate members and may be sent to NWS Headquarters **OR** included with the \$20 entry fee as a separate check:

Artists whose paintings are accepted will be provided a label to be attached to their work prior to shipping. Use Fed Ex or UPS for delivery to NWS. There will be a NWS handling fee of \$50 for SHIPPED work. The dates for walk-in hand deliveries will be sent in the acceptance letter.

FRAMING

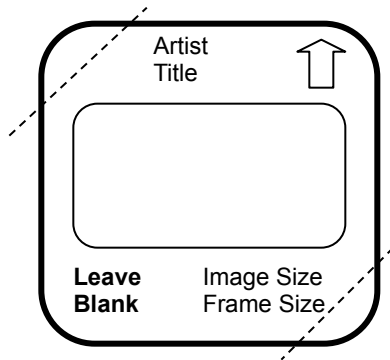
Minimum framed size is 9 x 12 inches. Maximum framed size is 50 inches in any one direction of either height or width. The frame must be simple but sturdy enough to support the weight of the art work. **PLEXIGLAS COVERING ONLY.** No glass will be accepted. Diptychs and other multiple image works must be within a single frame. The **FRAME** must be light enough for one person to handle. The painting must be ready for hanging with wire. No saw-tooth hangers. Mats, if used, must be white or light neutral.
